2. Call for Papers: 2015 Doctoral Colloquium

A Doctoral Colloquium will be held in conjunction with the **APMAA 2015** Annual Conference. Doctoral students and candidates are hereby invited to present and discuss their preliminary results or work-in-progress. The discussants comprise of a group of international Professors.

Doctoral students interested in participating in the doctoral colloquium should submit a single PDF file consisting of:

- 1. An introductory letter in which you indicate what you wish to obtain from the doctoral colloquium and what you will be bringing to the doctoral colloquium.
- 2. A one page research statement on the research you will pursue. If you are at the doctoral dissertation stage, this statement should focus on the dissertation.
- 3. Your CV.
- 4. A letter of recommendation from your primary dissertation advisor, who should state what you can contribute as well as gain from the doctoral colloquium.
- 5. Your paper (The text should be about 4,000-8,000 words).
